

Yanbal USA, INC Fun in the Sun Giveaway Rules

1. Eligibility

This FUN IN THE SUN GIVEAWAY (“Giveaway”) is open only to those who complete the Required Actions (as defined herein) at [Giveaway Instagram URL] and who are 18 years of age or older as of the date of entry. The Giveaway is only open to legal residents of the United States, and is void where prohibited by law. The Giveaway is subject to all applicable federal, state, and local laws and regulations. 2. Sponsor

3. Agreement to Rules

4. Giveaway Period

Entries will be accepted online starting on Friday, June 28 at 10:00 a.m. EST. All online entries must be received by Sunday, July 7 at 11:59 P.M. EST.

5. How to Enter
